
The objects of every District Council shall be to promote and protect within the district the rights of the consumers laid down in clauses (a) to (f) of Section 6 of The Consumer Protection Act, 1986.

The Council may meet at such time and place as the Chairman may decide but not less than 02 (two) meetings shall be held every year. A notice of meeting may be issued under the signature of the Member Secretary and at least 5 clear days notice shall be given for such a meeting.

The Council may constitute from amongst its members such working group as it may be necessary and working group so constituted shall perform such functions as may be assigned to it by the Council.

The Council may adopt its own procedure and method of working. It may pass resolution recommendations for any matters, enumerated in the Act. A copy of such resolution may be sent to the Administrator for consideration and necessary action.

The Civil Supply Officer, Daman will be ex-facto Member Secretary of the Council. He will be responsible for calling all the meeting of the Council.

The functions of the Council shall be laid down in Section 6 of the Consumer Protection Act, 1986.

- (a) *the right to be protected against the marketing of goods and services which are hazardous to life and property;*
- (b) *the right to be informed about the quality, quantity, potency, purity, standard and price of goods or services, as the case may be so as to protect the consumer against unfair trade practices;*
- (c) *the right to be assured, wherever possible, access to a variety of goods and services at competitive prices;*
- (d) *the right to be heard and to be assured that consumer's interests will receive due consideration at appropriate forums;*
- (e) *the right to seek redressal against unfair trade practices or restrictive trade practices or unscrupulous exploitation of consumers; and*
- (f) *the right to consumer education*

The Council may meet at such time and place as the Chairman may decide. A notice of meeting may be issued under the signature of the Member Secretary and at least 7 clear days notice shall be given for such a meeting.



The Council may constitute from amongst its members such working group as it may be necessary and working group so constituted shall perform such functions as many be assigned to it by the Council.

The Council may adopt its own procedure and method of working. It may pass resolution recommendations for any matters, enumerated in the Act. A copy of such resolution may be sent to the Administrator for consideration and necessary action. A copy of the resolution may also be sent to the Central Government.
