ORDER

Whereas, vide this office order quoted above, the building known as Biblos Market, situated at Zapabar, Near C.P. Shah Petrol Pump, Daman Vapi Main Road, Nani Daman was declared unsafe and unfit for human habitation and entry and occupancy of any part of the said building was prohibited.

And whereas, it is noticed that the said building is still being used for human habitation.

And whereas, the Chief Officer, Daman Municipal Council, Daman vide his letter No. 4/9-1/95-DMC/01-02/14-15/473 dated 05/06/2014 has submitted Condition Assessment Report of the said building conducted by the experts of S.V. National Institute of Technology, Surat (Gujarat) Dr. Atul K. Desai and Dr. Krupesh A. Chauhan.

And whereas, in the Condition Assessment Report the team has concluded that this building is in "**extremely dangerous**" condition in the present state and may collapse at anytime and the team has insisted immediate evacuation of building and sealed for human occupancy, as it is not only dangerous for occupants of the building but also to the nearby buildings, pedestrians and vehicular traffic on the roads.

Now, therefore, I, Ramesh Verma, District Magistrate, Daman in exercise of the power conferred upon me by **Section 144 of Code of Criminal Procedure, 1973 (No.2 of 1974)** do hereby once again declare that the aforesaid building is unsafe and unfit for human habitation and prohibit entry and occupancy of any part of the building and the occupants of the said building are hereby directed to evacuate the building **within 7 days period**, failing which the Administration shall take necessary action to evacuate them and violation of this order shall entail punishment under appropriate section of Law.
