ORDER

Where as due to the situation prevailing in the area of the following Police Station/ Out posts, it is apprehended that terrorist/ anti-social elements may seek hideouts in the area of the said Police Station/ Out posts and there is every likelihood of breach of peace and disturbance of public tranquility and also there is grave danger to human life and safety and injury to public property on that account:-

And where as it is necessary that some checks should be put on landlord/ Hotel/ Guest house/Lodge/Chawl owners so that terrorists/ Anti-Social elements in the guise of tenants/ visitors/guests may not cause explosion, riots, shootouts, affray etc. and that immediate action is necessary for the prevention of the same.


Now, therefore, I, Ramesh Verma, District Magistrate, Daman in exercise of the powers conferred upon me by Sec. 144 of Code of Criminal Procedure, 1973 (No.2 of 1974), do hereby order that no Landlord/ Hotel/ Guest House/ Chawl owners shall let/ sublet/ rent out any accommodation to any person unless and until he has obtained the copy of any reasonable document of identity –proof (like Election I. D. Card, PAN Card, Driving licence, Passport, Credit Card, Debit Card and any other reasonable proof of identity) of the said tenants/ visitors/guests which falls under the jurisdiction of the area of the Police Station/ Out posts as specified above in this order and unless and until he has furnished the particulars of the said tenants/ visitors/ guests to the Officer in-Charge of the Police Station/ Out posts concerned. All persons who intend to take accommodation on rent shall inform in writing in this regard to officer-in-Charge Police Station/ Out posts concerned in whose jurisdiction the premises falls. The person dealing in the property business shall also inform in writing to the In-Charge Police Station concerned in whose jurisdiction the premises falls about the particulars of the said tenants.

This order shall come into force w.e.f. 11-05-2014 and shall be effective for a period of 60 days i.e. up to 09/07/2014 (both days inclusive) unless withdrawn earlier.

Any person contravening this order shall be punishable under section 188 of the Indian Penal Code.

As the notice can not be served individually on all concerned, the order is hereby passed ex-parte. It shall be published for the information of public through media and also affixing the copies of the order on the notice-board of all the offices of U.T. Administration of Daman including the office of the IG (P)/ DD & DNH, Superintendent of Police, Additional Superintendent of Police, Officer Sub-Divisional Police, all Police Station/ Out post/ SFO concerned and the office of the Municipal Council and District Panchayat of Daman.
