

Director of Education shall organize competitive debates/lectures /easy writing competitions on moral values, ethics, good governance practices etc. amongst the employees and colleges/schools in local areas and to distribute prizes. All Head of Offices are requested to organize suitable programmes for sensitizing the staff about need for responsive, people friendly, transparent & sensitive governance and administration.

All the Head of Offices shall observe the Vigilance Awareness Week by carrying out the following activities:-

- i. To display banners, posters etc. at prime locations in their office;
- ii. To display banners, posters etc. at prime placed with public interface such as Branches of the bank, Petrol pumps Railway Stations, Airports.
- iii. To carry out media campaign at an appropriate scale on anti-corruption.
- iv. To organize competitive debates/lectures/easy writing competitions on anti-corruption topics amongst the employees and the students in the colleges/ schools and to distribute prizes;
- v. To bring out special issue on journals during the period; and
- vi. To request the non-government organizations, institution and service associations in the local area to participate in the Vigilance Awareness campaign.

All the recognized political parties in Daman are also requested to organize similar awareness programmes at the party level and sensitize them about the need for responsive, people friendly, transparent & sensitive governance.
