At the outset the Collector, Daman welcomed the Hon'ble Joint Secretary (DBT), Govt. of India, Ministry of Finance and also other participants.

The Deputy Secretary (Food & Civil Supplies) gave the PowerPoint presentation regarding the current status of TPDS and thereafter consultant of M/s. Wipro gave the details about the NFSA and End – to- End Computerization of TPDS to be implemented in the U.T Administration of Daman & Diu.

The worthy Collector stated that this U.T has chosen the Model-ii i.e Subsidised Foodgrains Delivery involving biometric authentication as mentioned in the letter of Joint Secretary Govt. of India, Ministry of Consumer Affairs, Food & Public Distribution, Department of Food & Public Distribution, Krishi Bhawan, New Delhi , Vide D.O. letter No. 14 (7)/2014-COMP dated 15.05.2015.

The U.T Administration has covered 71.39% of the Aadhaar seeding of the beneficiaries under NFSA, which is required to be brought up to 100% as per the direction of Govt. of India, Ministry of Consumer Affairs, rest of the beneficiaries will be covered as the UT Administration is in process for procurement of hardware devices for the CSC workers in which Permanent Enrolment Centers are established.

The POS could not be installed at the FPS because it was a part of RFP which was already floated for end to end computerization of TPDS in which M/s Wipro is a Consultant Company.


The Joint Secretary DBT stated that because the U.T has opted the model – ii, so administration has to apply for AUA. Further he stated that it should be checked that there is no de duplication of Aadhaar number given by the beneficiaries. The POS should be installed at all the Fair Price Shops in Daman & Diu and their owners should be trained for operating the devices. He was of the suggestion that these devices may be purchased with the help of NIC from the companies having specification of STQC. As the department has no men power, so it was suggested by the Joint Secretary that scope of work of the consultant, M/s Wipro can be expanded, Wipro can be asked to provide 4 or 5 technically qualified persons to train the FPS owners, if it is adopted, the department will have to rethink its RFP.

The Collector, Daman has noted the suggestions given by the Joint Secretary (DBT), Government of India and assured to meet timelines.

The matter regarding establishment of Permanent Enrolment Center was also discussed by the Additional Director General, UIDAI with the Collector and NIC's Team, Daman.

The meeting ended with a vote of thanks.
