ORDER UNDER SECTION 144 OF CRIMINAL PROCEDURE CODE


Whereas, the Public hearing to objectors will be held for disposal of the objections/suggestions against the proposed delimitations of District Panchayat wards, Daman on 16.07.2015 at 10.30 a.m. at Collectorate, Moti Daman and objectors in huge numbers will attend the said hearing.

Whereas the holding of Public meeting, Dharna, Rally, use of Loud Speaker, slogan shouting etc, at the Main Road from Dholar, Char Rasta to Gate of the Fort at Moti Daman causes inconvenience to the general public and adversely effects the smooth flow of vehicular traffic as well as may interrupt the smooth proceeding of the said public hearing at Collectorate, Moti Daman. It also endangers law and order situation for the sensitive offices in the Fort Area/Secretariat and Collectorate, Moti Daman.

Therefore, in exercise of the powers under section 144 of Code of Criminal Procedure, 1973 (No. 2 of 1974), I Mitali Namchoom, District Magistrate, Daman hereby order that holding of public meeting, Dharna, Rally or gathering of Public for celebrating any function or gathering by any private associations/organizations, political parties or groups at the Main Road from Dholar, Char Rasta to the Gate of the Fort, Moti Daman and in the radius of 100 Mtrs. of the Government VVIP Circuit House, Dholar, Moti Daman is strictly prohibited with a view to avoid any untoward incident or law and order problem in the future and any such activity can be held only after taking prior permission of the District Magistrate.

The order shall come into force and shall be effective with immediate effect for a period of 05 days from 15.07.2015 to 19.07.2015 (both days inclusive) unless withdrawn earlier.

Any person contravening this Order shall be punishable under Section 188 of the Indian Penal Code.
