ORDER UNDER SECTION 144 OF CRIMINAL PROCEDURE CODE

Whereas, due to logistical issues the Public hearing of objectors for the disposal of the objections/suggestions against the proposed delimitations of District Panchayat wards, Daman on 16.07.2015 at 10.30 a.m. will be held at the Swami Vivekanand Auditorium Hall, Nani Daman and objectors in huge numbers will attend the said hearing.

Whereas the holding of Public meeting, Dharna, Rally, use of Loud Speaker, slogan shouting etc, at the Main Road, Govt. College, Nani Daman may cause inconvenience to the general public and adversely effect the smooth flow of vehicular traffic as well as may interrupt the smooth proceeding of the said public hearing at the Swami Vivekanand Auditorium Hall, Nani Daman. It may also endanger the law and order situation.

Therefore, in exercise of the powers under section 144 of Code of Criminal Procedure, 1973 (No. 2 of 1974), I Mitali Namchoom, District Magistrate, Daman hereby order that holding of public meeting, Dharna, Rally or gathering of Public for celebrating any function or gathering by any private association/organization, political party or group at the Swami Vivekanand Auditorium Hall, Nani Daman and in the radius of 100 Mtrs. of the Swami Vivekanand Auditorium Hall, Nani Daman is strictly prohibited with a view to avoid any untoward incident or law and order problem in the future and any such activity can be held only after taking prior permission of the District Magistrate.

The order shall come into force and shall be effective with immediate effect for a period of 01 day from 16.07.2015 at 8.30 a.m. to 6.00 p.m. unless withdrawn earlier.

Any person contravening this Order shall be punishable under Section 188 of the Indian Penal Code.
